Members of VCCA attend the National Shift Conference in Miami

VCCA General Assembly News:

This has been a very busy General Assembly session for VCCA Lobbyist Matt Benedetti and Josh Myers. For child care and early education directly the most important legislation this session is House Bill 1012 (HB 1012) & the Senate version which is Senate Bill 578 (SB 578). This bill will transfer all of early education from the authority of the Department of Social Services to the Department of Education. This bill IS expected to pass. Matt and Josh are closely monitoring the governor's budget to include as much money for public-private "Mixed Delivery" partnerships as possible.

SUMMARY AS INTRODUCED:

Early childhood care and education; licensing. Requires the Board of Education to establish a statewide unified public-private system for early childhood care and education in the Commonwealth to be administered by the Board of Education, the Superintendent of Public Instruction, and the Department of Education. The bill transfers the authority to license and regulate child day programs and other early child care agencies from the Board of Social Services and Department of Social Services to the Board of Education and Department of Education. The bill maintains current licensure, background check, and other requirements of such programs. Such provisions of the bill have a delayed effective date of July 1, 2021. The bill requires the Superintendent of Public Instruction to establish a plan for implementing the statewide unified early childhood care and education system and requires the Department of Social Services and the Department of Education to enter into a cooperative agreement to coordinate the transition. The bill also requires the Board of Education to establish, no later than July 1, 2021, a uniform quality rating and improvement system designed to provide parents and families with information about the quality

and availability of certain publicly funded early childhood care and education providers and to publish the initial quality ratings under such system in the fall of 2022.

The other bills that may impact our industry (most are not early care & education related) are listed below. Among these include an increase in the minimum wage and paid family medical leave. Matt and Josh have been working with other like associations to speak on behalf of businesses that will be impacted as a result of these potential changes.

Although not finalized, at this point minimum wage is expected to increase to \$9.00-\$10.00 on July 1, 2020 and increase up by one dollar each year until 2025. The bill on Family Medical Leave act is expected to impact businesses with 5 or more employees and will accrue based on the time the employee builds up at work. Again, while none of this is finalized and all being worked out among many stakeholders in the state. Matt & Josh want our members to know that they are working on behalf of early childcare business to advocate for as small a fiscal impact as possible. Each change will have an impact on what families will have to pay to cover these expenses. We want to keep childcare and early education affordable and accessible to families of the commonwealth.

VCCA Minimum Wage Poll

- ♦ The recent VCCA poll on minimum wage revealed that members favored a max minimum wage of between \$9.00 and \$10.00 per hour.
- Most responded that they do not start employees off at the current minimum wage.
- ♦ The average starting minimum wage among responding members was \$8.75. Members expressed that they were very concerned that a minimum wage of \$15.00 could put them out of business
- ♦ Tuition would definitely have to increase to help cover the wage hike.
- ♦ We'll keep you posted as we know more.
